 - c. Detention Pond Erosion project;
 - d. update on wastewater treatment plant improvements;
 - e. deeds, easements, plants, and consent to encroachments;
 - f. capital improvement plan;
 - g. update on Bond Issue No. 10; and
 - h. update on Surplus Funds Application.

9. Phase II Small MS4 General Permit.
