 - a. Lift Station No. 1 backup generator;
 - b. Benton Road Commercial Site;
 - c. Detention Pond Erosion project;
 - d. update on wastewater treatment plant improvements;
 - e. deeds, easements, plants, and consent to encroachments; and
 - f. capital improvement plan.

8. Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training, public comment, and approval of year 1 annual report and public education materials.
