

NOTICE OF MEETING

FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 155

The Board of Directors of Fort Bend County Municipal Utility District No. 155 will hold a regular meeting on **Thursday, October 9, 2025, at 3:30 p.m.**, at Bonbrook Plantation Recreational Center, 9210 Reading Road, Rosenberg, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Security matters, including:
 - a. Fort Bend Constable's report.
3. Approve minutes.
4. Financial and bookkeeping matters, including:
 - a. payment of bills and review of investments, if appropriate;
 - b. review, revise, and adopt Resolution Establishing the Authorized Depository Institutions and Adopting List of Qualified Broker/Dealers with Whom the District May Engage in Investment Transactions; and
 - c. conduct annual review of Investment Policy adopt Resolution Regarding Annual Review of Investment Policy.
5. Operation of District, including:
 - a. water, sanitary sewer, and drainage facilities, billings, repairs and maintenance, irrigation meter usage, utility surveying, and meter replacements; and
 - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
6. Engineering matters, including approval of any pay estimates, change orders, design, plan and specification authorizations, advertisement of bids, award of contracts, letter financing agreements, and maintenance agreements, including:
 - a. Benton Road Commercial Site;
 - b. Lift Station No. 1 rehabilitation project;
 - c. update on joint facilities;
 - d. deeds, easements, plants, and consent to encroachments;
 - e. capital improvement plan; and
 - f. other engineering matters.
7. Update on detention/amenity lakes maintenance.
8. Phase II Small MS4 General Permit and Storm Water Management Plan, and authorize appropriate action.

9. Update on landscape maintenance and irrigation from GreenScape Associates, including:
 - a. District park and recreation improvements, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct landscape architect to notify insurance company of acceptance of projects:
 - i. Bonbrook Lake C Trails;
 - b. proposals for maintenance and repairs; and
 - c. update on detention/amenity lakes maintenance.
10. District communications, including website, mass messaging, social media policies, and authorize appropriate action.
11. Garbage and recycling matters.
12. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
13. Approve Annual Report and authorize filing of same with appropriate information depositories in accordance with the District's Continuing Disclosure of Information Agreement and as required by SEC Rule 15c2-12.
14. Annual Review of Procedures for Continuing Disclosure Compliance.
15. AWBD Bylaws Vote and Voter Representative Confirmation.
16. Discuss consultant contracts and authorize appropriate action.
