

NOTICE OF MEETING

FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 155

The Board of Directors of Fort Bend County Municipal Utility District No. 155 will hold a regular meeting on **Thursday, June 11 2026, at 3:30 p.m.**, at Bonbrook Plantation Recreational Center, 9210 Reading Road, Rosenberg, Texas, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Security matters, including:
 - a. Fort Bend Constable's report.
3. Approve minutes.
4. Review Arbitrage Rebate Report for the Series 2021 Bonds.
5. Financial and bookkeeping matters, including payment of bills and review of investments, if appropriate.
6. Operation of District, including:
 - a. water, sanitary sewer, and drainage facilities, billings, repairs and maintenance, irrigation meter usage, utility surveying, and meter replacements; and
 - b. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
7. Approve Risk and Resilience Assessment and filing of certification of same with the Environmental Protection Agency.
8. Engineering matters, including approval of any pay estimates, change orders, design, plan and specification authorizations, advertisement of bids, award of contracts, letter financing agreements, and maintenance agreements, including:
 - a. Benton Road Commercial Site;
 - b. update on joint facilities;
 - c. discuss summary of cost for proposed bond application;
 - d. deeds, easements, plants, and consent to encroachments;
 - e. capital improvement plan; and
 - f. other engineering matters.
9. Authorize engineer to prepare bond application.
10. Update on detention/amenity lakes maintenance.
11. Phase II Small MS4 General Permit and Storm Water Management Plan, and authorize appropriate action.

12. Update on landscape maintenance and irrigation from GreenScape Associates, including:
 - a. District park and recreation improvements, including authorize design, approve plans and specifications, authorize advertisement for bids, review bids and award contracts, approve pay estimates and change orders, authorize final acceptance of projects, and direct landscape architect to notify insurance company of acceptance of projects;
 - b. proposals for maintenance and repairs; and
 - c. update on detention/amenity lakes maintenance.
13. District communications, including website, mass messaging, social media policies, and authorize appropriate action.
14. Garbage and recycling matters.
15. Tax assessment and collections matters, including delinquent tax collections, installment agreements, and payment of tax bills.
16. Approve First Amendment to Interlocal Cooperation Agreement for the Collection of Taxes with Fort Bend County.
17. Authorize Delinquent Tax Attorney to proceed with collection of delinquent taxes.
18. Adopt Resolution Nominating Candidate for Board of Director Election for Fort Bend Central Appraisal District.
